

**Orange County Board of Elections Resolution Number 2017- 003:
To divide the Town of Blooming Grove into a Ward System**

WHEREAS, The Town of Blooming Grove voted on and approved going to a Ward System in November of 2016; and therefore based on the results of that election the Election Districts in the Town of Blooming Grove needed to be broken into Wards and;

WHEREAS, The Town of Blooming Grove contains the Village of Washingtonville which has a population greater than 5,000 and therefore its election districts need to be coterminous with the Village boundaries; and **FURTHER**, the Town of Blooming Grove also contains the Village of South Blooming Grove which has a population of less than 5,000 and therefore its election districts do not need to be coterminous with the Village Boundaries, and;

WHEREAS, pursuant to the State of New York 2016 Election Law § 4-100. 1-5, the creation, consolidation, and division of Election Districts shall be done by the Board of Elections, and pursuant to the State of New York 2016 Election Law § 4-102-5.c. pertinent copies of such maps shall be filed and kept open to public inspections; and

WHEREAS, the Orange County Board of Elections has established the following new Election Districts within the Ward boundaries of the Town of Blooming Grove:

Ward 1	Districts 1 - 4
Ward 2	Districts 1 - 3
Ward 3	Districts 1 - 4
Ward 4	Districts 1 - 3
Ward 5	Districts 1 - 5
Ward 6	Districts 1 - 4

and has filed maps thereof; and

WHEREAS, pursuant to State of New York 2016 Election Law § 4-104.1-8, every Board of Elections shall, **in consultation with each city, town and village**, designate polling places in each Election District in which the meetings for the registration of voters and for any election may be held; and

WHEREAS, the Board of Elections shall establish said polling places and notify all voters in the Town of Blooming Grove their new Ward & Election District Number as well as their new polling place, and;

WHEREAS, the following Election Districts within the boundaries of the Town of Blooming Grove have been re-aligned to conform to Section 4-100-3 (a) of the NYS Election Law:




